REQUIREMENTS FOR MATERIALS

The conference report is submitted in MS Word and pdf format, written in Ukrainian, English or Russian. Page format – A4. Margins: 2 cm left, 2 cm right, 2 cm top and 3 cm bottom. All pages of the article should be numbered at the bottom, in the center. Volume of materials - up to 3 pages.

Formulas are typed in the formula editor (Equation 3.0 or MathType) using only Latin and Greek letters. It is not allowed to use Cyrillic letters, in particular, in indexes. Each formula is typed as one object (full - 11 pt; subscript - 8 pt; subsubscript / superscript - 6 pt, symbol - 10 pt).

Illustrations are submitted as included in the text of the article after the first link to them.

The structure of materials:

- 1. In the upper left corner of the article you need to specify the UDC index (Times New Roman, 11 pt, left).
- 2. Initials and surnames of the authors (print in bold, each on a new line) (Times New Roman, 14 pt, right).
- 3. Through a blank line the title of the article (in bold, in the center, Times New Roman, 16 pt)).
- 4. The names of the institutions where the authors work are indicated through a blank line (Times New Roman, 11pt, center).
- 5. Through a blank line entitled (bold) "Abstract" the abstract of the article in English (Times New Roman, 10 pt, italics, page width).
- 6. From a new line called (bold) "Keywords:" is a list of keywords in English (Times New Roman, 10 pt, page width), separated by a semicolon.
- 7. The main text of the article (Times New Roman, 11 pt, page width, with line spacing "Single").
- 8. The LIST OF USED LITERATURE, drawn up in the form of a general list, which is compiled in the order of references in the text. In the text of the article the references to the literature are taken in square brackets (for example, [1, 2]).
- 12. Information about the authors: surname, name (without abbreviations, bold, italics), scientific degree, academic title, position, full name of the institution, city, e-mail address of the person responsible for the report author (Times New Roman, 10 pt, left).

Important information for authors.

- 1) Important dates:
- submission deadline no later than 01.02, 2023;
- information on inclusion of the manuscript in the monograph no later than 30.04 2023;
- publication of the collective monograph by Springer publishing house no later than 31.08. 2023.

(The dates may be changed due to the war between Russia and Ukraine and due to the global pandemic situation caused by COVID-19).

- 2) Articles must be formatted according to the standard Springer template and have a volume of 20-40 pages.
- 3) Number of authors must be no more than 5, with no more than 4 authors having the same affiliation. It is desirable (but not necessary) to have in the author's team a co-author(s) with a foreign affiliation.
- 4) Authors should submit only original works that were not published and are not being reviewed for another peer-reviewed publication. If authors used their previously published work(s) as the basis for a new publication, they

should cite the previous work(s) and very briefly indicate which new contributions the publication proposes apart those in the previously published work(s).

- 5) Plagiarism is unacceptable. Verbatim copying or reusing own research is also considered as a form of plagiarism or self-plagiarism; it is unacceptable. The similarity of the text, including own works, must not exceed 25%.
- 6) Excessive self-quoting is not desirable. Authors can make references to their works, provided that their content complements or contributes to better understanding the research material. The level of self-citation must not exceed 20% of the total number of references in the bibliography. The manuscript should not have an excessive list of references. The maximum number of references for manuscripts of 20 pages is no more than 30-40 references, and for manuscripts of 40 pages no more than 70-80 references. The references should be contemporary (for the last 5-8 years) and relevant.
- 7) All submitted manuscripts will be reviewed at three stages. The first stage review will be performed by members of the organizing committee of the conference (checking the manuscript content for compliance with subjects of the monograph and design requirements, checking the level of text matching). The second stage review will be performed by editors of the collective monograph (checking the scientific and practical aspects of the manuscript content). The third stage review will be performed by members of the Springer editorial board.
- 8) The publication (prepress preparation of the collective monograph section) costs 100€. Authors will receive payment notifications after passing the last third stage of the review. The payment must be in hryvnias according to the current NBU exchange rate on the day of payment. After the payment, the authors will receive confirmation on inclusion of their manuscript in the collective monograph.
- 9) Authors are not recommended to submit the full text of the manuscript as a preprint. This may cause rejection of the manuscript at some stage of the editorial process.
